- 1) Physical health & safety
- 2) Contract flexibility
- 3) Financial security

Who are the Secure Vendor Program Members?

This directory provides clients with the global list of vendors who have signed on with the Secure Vendor Program and pre-certified that they will accept the escrow of advance deposits until program delivery. These forward-thinking industry suppliers are making a clear commitment to financial transparency, accountability and responsibility. They will not be running their businesses today with your deposits that are meant to secure services for your program taking place in the future.



Gold members accept that 100% of the advance deposits required for the services they are proposing can be held securely in escrow until program delivery. Gold membership is for hotels and venues, as well as DMCs or other suppliers who broker local services on your behalf and have either negotiated payment terms or, with the assurance of your full program deposits in escrow, are willing to pay any sub-vendor advance deposit requirements.



Silver members accept that 100% of advance deposits required for the services they are proposing can be held securely in escrow until program delivery, with the exception of any local sub-vendor deposits required to guarantee services. They commit to providing you with clear cancellation and Force Majeure eligibility for any amounts released in advance of program delivery. Silver membership is designed for DMCs and other suppliers who broker local services on your behalf.

How can I work with Secure Vendor Program members?

Step 1 is to become a client of Meeting Escrow which gives access to our wide range of financial and risk management solutions, including the global network of Secure Vendor Program members who accept the escrow of advance deposits.

Step 2 is to modify your RFP requirements (which we can provide RFP verbiage) to mandate that any hotel, venue, DMC or other vendor wishing to bid on your services must be a Gold or Silver member of the Secure Vendor Program.
